Humana Medicare Supplement Premium Rate Changes effective March 1, 2021

Body:

Monthly premium rates are changing for our **2010/MIPPA Humana Medicare Supplement Plans.**

As of **March 1, 2021**, changes are as follows:

- **Maryland:**
 - 9.0% increase to Plans A and N
 - 5.5% increase to Plan G
 - 5.0% increase to Plan C
 - 2.7% increase to Plan F
 - 0.0% increase to Plans B, F(HD), G(HD), K and L

Note: Plans B, F(HD), G(HD), K and L will renew at current rate.

- **Michigan:** 10.% increase to Plans A, C and D

Note: These plans are only available via paper applications

- **Minnesota:**
 - 10.0% increase to Basic, Copay and 75% Coverage Plans
 - 6.5% increase to Extended Basic and 50% Coverage Plan
 - 3.2% increase to Riders 1, 3, 4 and 5
 - 7.0 increase to Rider 2
 - 0.0% increase to High Deductible Plan

Note: Plan High Deductible will renew at current rate.

- **Oregon:**
 - 10.0% increase to Plan A
 - 7.0% increase to Plans C, F and G
 - 5.5% increase to Plans B, K and L
 - 3.0% increase to Plan N
 - 0.0% increase to Plans F(HD) and G(HD)

Note: Plans F(HD) and G(HD) will renew at current rate.

- **Utah:** 8.5% increase to Plans A, F, G and N
0.0% increase to Plans F(HD) and G(HD)

Note: Plans F(HD) and G(HD) will renew at current rate.

Monthly premium rates are changing for our **Humana Healthy Living Medicare Supplement Plans**

As of **March 1, 2021**, changes are as follows:

- **Alabama:** 0.0% increase to Plans A, F, F(HD), K and N
0.0% increase to Innovative Benefits (Dental and Vision)

Note: All plans and Innovative Benefits (Dental and Vision) will renew at current rate.

- **Tennessee:** 5.5% increase to Plan A
7.5% increase to Plan F
9.0% increase to Plan N
0.0% increase to Plans F(HD) and K
0.0% increase to Innovative Benefits (Dental and Vision)

Note: Plans F(HD) and K and Innovative Benefits (Dental and Vision) will renew at current rate.
